

1. Introduction




Figure 2: N Prince Street/Commerce Way Intersection

The purpose of this report is to summarize the crash report data that was provided by the City of Clovis for the intersections of N Prince Street/Commerce Way and N Prince Street/E 21st Street in Clovis, NM. A map indicating the location of the study intersections can be found in Appendix A and aerial photographs of each intersection are shown in Figure 1 (N Prince Street/E 21st Street) and Figure 2 (N Prince Street/Commerce Way).

The N Prince Street/E 21st Street intersection is located 400-feet north of the N Prince Street/Commerce Way Intersection. Adjacent signalized intersections are located approximately 0.4 miles north and south of the intersections. The N Prince Street corridor is one of the major north/south routes through Clovis and provides access to numerous commercial, retail and residential developments. Commerce Way links N Prince Street to N Main Street and the Historic Preservation and Business District in downtown Clovis. The E 21st Street corridor is one of the major east/west routes through Clovis and provides access to numerous commercial, retail and residential developments, including Clovis High School.

The purpose of the analyses were to document and catalogue each of the crashes at each intersection, map each of the crashes by intersection approach, and identify relevant crash patterns and statistics.

2. Intersection Crash Analysis

Intersection crash reports for the three-year period from 2010 to 2012 were provided by the City of Clovis. Only crashes that were reported to a public safety agency (e.g., Clovis Police Department) and transmitted to the Clovis Police Department are included. It has been estimated that only 50% of the total number of crashes that occur are actually reported. Refer to **Appendix B** for a description of crash rate calculations

2.1 N Prince Street/Commerce Way

A total of 44 crashes were reported for the three-year period analyzed. **Table 1** provides a summary of the crash statistics for the predominant crash types. Refer to **Appendix C** for a listing of the summarized crash data for the intersection and **Appendix D** for the collision diagram for the intersection.

In addition to the statistics summarized in **Table 1**, other pertinent crash statistics are:

- The three-year crash rate at the intersection is 1.52 crashes per million entering vehicles (cr/MEV).
- Five of the 44 reported accidents (11%) involved injuries. This falls below the New Mexico Statewide average (30%) and City of Clovis average (23%) for 2010 (taken from the NMDOT New Mexico Traffic Crash Annual Report 2010). There were no fatalities.
- The predominant crash types are rear-end and left-turn crashes.
- Two of the crashes involved a pedestrian and both involved a northbound moving vehicle.
- One of the crashes involved alcohol.
- Thirty-three of the 44 crashes (75%) involved a northbound.

- Ten of the 44 crashes (22%) occurred between 10:00 AM and 1:00 PM, and thirteen of 44 crashes (30%) occurred between 4:00 PM and 6:00 PM. Only 2 crashes (5%) occurred between 6:00 AM to 9:00 AM.
- The top contributing circumstances include following too close (43%), disregarding traffic signal (15%), and driver inattention (14%).

2.2 N Prince Street/E 21st Street

- The predominant crash types are rear-end and angle crashes.



- One of the crashes involved a pedestrian in a southbound moving vehicle.
- One of the crashes involved alcohol.
- Thirty-six of the 84 crashes (43%) involved a southbound movement.
- Nineteen of the 84 crashes (23%) occurred between 10:00 AM and 1:00 PM, and fourteen of 84 crashes (17%) occurred between 4:00 PM and 6:00 PM. Only 4 crashes (5%) occurred between 6:00 AM to 9:00 AM.






The top contributing circumstances include following too close (42%), failed to yield right of way (24%), and driver inattention (7%).

CRASH RATE FORMULAS

The standard formula for Segment Crash Rate is:

For measuring units of Crashes per 100 million vehicle-miles,

Rate (segment) = (C * (10 exponential 8))/(365*T*V*L)

Where: C = number of crashes over number of years studied that occurred on the segment;

365 Days/Year

T = number of years

V=AADT=vehicles/Day

L = Length of segment in miles

To convert to measuring units of crashes per million vehicle-miles, divide by 100.

For intersection Spot Crash rates the standard formula, measured in Crashes per 100 million entering vehicles is:

Rate (Intersection) = (C * (10 exponential 8))/ (365*T*V[entering])

Where: C = number of crashes over number of years that occurred in the intersection or are intersection related:

365 Days/Year

T = number of years

V[entering] = vehicles per day entering the intersection (one-way) from all approaches to the intersection. To convert to measuring units of crashes per million entering vehicles, divide by 100.

If you only have regular ADT Volume (two-way) data, then substitute V[ADT]/2 for V[Entering], and the formula is then:

Rate (Intersection) = (C * (10 exponential 8))/(365*T*(V[ADT[2)))


