**CITY CONTINUING TO ALLOCATE FUNDS FROM FIRST ROUND OF CARES ACT**

CLOVIS, NM - The City of Clovis has begun allocating grant awards to local businesses as part of the first installment of the New Mexico CARES Small Business Continuity Grant. The City initially received a \$4,260,000.00 award from the State of New Mexico to assist businesses with expenses related to the COVID-19 pandemic.
